Commitment to legality and values

- **#3** Provide all necessary means to disseminate the values of Molins Defensa Penal and enforce compliance with the guidelines of this Code of Ethics.
- **#4** React appropriately to cases of non-compliance with this Code of Ethics.



Commitment to the Firm and its members

Respectful treatment and non-discrimination

Molins Defensa Penal undertakes to maintain a working environment free of any discrimination and of any conduct linked to a situation of harassment in any of its manifestations.

At Molins Defensa Penal we do not tolerate abusive, hostile or offensive behaviour, whether verbal or physical.

Equal opportunities

At Molins Defensa Penal we have a professional development plan which, among other aspects, manifests an effective **policy of equal opportunities** for all our professionals to develop their professional activity on the basis of the **principle of merit**. Thus, promotion decisions are based on objective assessment criteria.

Health and safety at work

At Molins Defensa Penal we provide a safe and stable working environment. To this end, we provide **regular training in the occupational risk prevention**. We also keep the occupational risk prevention measures up to date.

Money laundering

At Molins Defensa Penal we are aware of the importance of complying with all current regulations on the prevention of money laundering and the financing of terrorism. To this end, we not only carry out training activities, but we also have internal prevention protocols and policies in this area.





Commitment to third parties

With our clients

At Molins Defensa Penal, the client is the main focus of our activity. For this reason, we are committed to providing a quality service with the highest possible professionalism. With the market

At Molins Defensa Penal we are concerned with offering truthful information in the promotional activities we carry out, without tolerating the offering of false information to our clients. Therefore, through this Code of Ethics we categorically reject the following:

#1 Engaging in any type of misleading advertising through the Firm's media.

#2 Discovering, disclosing, releasing or disseminating sensitive or proprietary information to which our members have access.

With partners and suppliers of services and products

In its relationship with external collaborators and suppliers, Molins Defensa Penal is based on the principles of trust, loyalty, transparency, reciprocal collaboration and confidentiality. Molins Defensa Penal undertakes to make this Code of Ethics available to its collaborators so that its provisions are not contravened. Similarly, we expect our suppliers to comply with the legal requirements applicable to their business relations.

With the public administration

In our relations with members of any Public Administration, all the members of Molins Defensa Penal faithfully respect the provisions of the regulations in force and the internal regulations of the organisation. In this sense, we adhere to the principle of transparency. Thus, contacts with the institutional representatives of any public administration are carried out by the representatives of Molins Defensa Penal designated for this purpose, who are accountable for the outcome of the meetings and negotiations.

Likewise, through this Code of Ethics, Molins Defensa Penal declares its absolute rejection of any practice linked to corruption in its relations with any member or representative of public administrations. Specifically, it is forbidden to offer, receive, request or accept an unjustified benefit or advantage of any kind in the contracting of services and/or in other commercial relations.

In the event that any of our collaborators or external suppliers adopt behaviour that does not comply with the law, Molins Defensa Penal may take the appropriate measures and may even refuse to collaborate in the future.

Molins Defensa Penal is prohibited from authorising the offering, either directly or indirectly, of anything of value to any supplier to obtain an undue advantage in the procurement.



With the environment

At Molins Defensa Penal we are aware of the importance of developing a sustainable and environmentally friendly activity.

Although the activity of Molins Defensa Penal does not constitute a high-risk activity for the environment, in our day-to-day work we adopt environmentally friendly conduct. Thus, among others, we have policies relating to recycling and *paperless*.



Commitments in relation to the activity of Molins Defensa Penal

Confidential information

We all have an obligation to protect the information we hold in relation to Molins Defensa Penal, as well as information relating to our customers and suppliers.

All members of Molins Defensa Penal must keep confidential all reserved and sensitive information to which we have access. Furthermore, we must preserve it so that it cannot be used inappropriately and refrain from using it improperly for our own benefit or that of third parties. This confidentiality includes friends and family members.

We also respect the information of our clients and collaborators and abide by the principles of confidentiality and privacy.

How we communicate information is key to us and our reputation, so we must all communicate it truthfully and under no circumstances provide incorrect, inaccurate or incomplete information that could mislead the recipient.




Use of resources
